INTRODUCTION

GREEN VALLEY INTERNATIONAL thanks you for selecting one of our quality products. Our commitment to you and your HAULIT® begins with quality protection and service in the unlikely event you require warranty service. GREEN VALLEY INTERNATIONAL is your first stop and primary contact. Certain warranty repairs require special training, tools and/or equipment. In such cases, it is the GVI's responsibility and prerogative alone to determine the best course of action and suitable facility to properly repair your HAULIT®. (See complete limited warranty for details.)

GREEN VALLEY HAULIT™ LIMITED WARRANTY

GREEN VALLEY INTERNATIONAL LLC, ("GVI") hereby warrants to the original purchaser of the HAULIT ("the Purchaser") that the GVI shall repair any defects with the HAULIT® purchased by the Purchaser relating to materials or workmanship and attributable to the GVI, subject to the limitations and exclusions set forth below. The warranties described below will hereafter be identified as "this Warranty". The term of this Warranty is measured from the date of the original purchase of the HAULIT by the Purchaser. THIS WARRANTY IS NOT TRANSFERABLE TO SUBSEQUENT OWNERS AND IS NOT APPLICABLE TO THE RENTAL OF ANY PRODUCTS.

THE HAULIT GVI'S STRUCTURAL SIX MONTH WARRANTY COVERAGE: The GVI warrants the following items, and only the following items, in materials and workmanship for a period of six months from the date of purchase by the Purchaser: main rails, cross members, tongue a-frame, structural welds, corner posts, headers, door structures, exterior metal, floors, lights, mechanical jacks, winches, interior walls and Extraction System Drive Motor.

ITEMS EXCLUDED FROM THIS WARRANTY: Items not covered by this Warranty: axles, axle components, tow in and tow out on axles, camber on axles, hydraulic lift system, and any other items not manufactured by the GVI. Some or all of the above items may have warranties from their respective manufacturers which GVI does not guarantee.

CLAIMS EXCLUDED FROM THIS WARRANTY: GVI is not responsible for claims relating to any of the following: (1) any type of defacing, including scratches, dents, chips, tears, or defacing on any surface not caused by GVI;(2) inadequate or improper routine maintenance; (3) damage from unauthorized repairs, abuse, misuse, neglect, or overloading (as determined by the Gross Vehicle Weight Ratio ("GVWR");(4) metal corrosion from fertilizers, cement, caustic chemicals.;(5) damage caused from improper hitch ball or tow vehicle hook up; (6) damage to any contents of the HAULIT, regardless of cause;(7) damage caused by loose or improperly torqued lug nuts;(8) paint, decals, or graphics regardless of cause;(9) off road usage;(10) damage from snow and/or ice accumulation on the HAULIT. (11) tow vehicle wiring;(12) tire alignment; (13) deterioration of paint or general appearance due to use or exposure; (14) damage caused by loose fasteners due to not maintaining necessary tightness of these items;(15) damage caused from towing a HAULIT; (16) damage caused by using a towing vehicle to tow a HAULIT whose weight exceeds the tow vehicle's manufacturer 's specification;(17) damage to any tow vehicle; (18) damage caused by acts of God or terrorism; (19) damage caused by theft or vandalism; (20) corrosion or rust damage; (21) variances in tongue/hitch weight caused by improper load configurations; (22) damages caused by excessive "point loads" (i.e., exceptionally concentrated load vs. a properly distributed load); (23) any commercial misuse or misapplication including, but not limited to, improper loading, negligence, alteration, accident, lack of reasonable operation and deficient maintenance.

THIS WARRANTY WILL BE VOIDED BY ANY REPAIR OR MODIFICATION TO THE HAULIT, OR ADDITION OF ACCESSORIES TO THE HAULIT, BY ANYONE OTHER THAN THE GVI OR AN APPROVED GVI SERVICE PROVIDER. GVI will not be responsible for work performed by a Non-GVI service center, unless the GVI gives prior written authorization. The GVI's determination of whether the HAULIT® has been abused or misused by the Purchaser is final and binding on the Purchaser regarding the Purchaser's rights under this Warranty. DO NOT REWIRE TRAILER; rewiring voids this warranty.

GVI'S OBLIGATION

GVI's sole obligation under this Warranty and Purchaser's sole remedy is for GVI to repair all defects in materials and workmanship covered by this Warranty. GVI will not be obligated, in any way, to replace the HAULIT or to refund the purchase price of the HAULIT unless GVI determines, in its sole judgment, that the trailer cannot be repaired. In addition, GVI shall not be obligated to pay for any repairs made to the HAULIT® by or on behalf of the Purchaser without express prior written approval by GVI. GVI will attempt to remedy all defects within a reasonable time.

In the instance of a warranty claim and parts are required to be ordered/shipped, GVI will provide free GROUND shipping through USPS, FEDEX, UPS, or any other mailing service. If the customer party is in need of faster shipping, the customer will need to decide the best method for their needs and pay the remaining balance above the cost of ground shipping

THE PURCHASER'S OBLIGATIONS- HOW TO OBTAIN WARRANTY SERVICE

The Purchaser must notify GVI of any defects in material or workmanship immediately upon discovery of the defect. It is Purchaser's responsibility to notify GVI of any warrantable issues and to request authorization and replacement warranty parts.

The Purchaser is required to have the trailer registered within thirty (30) days of purchasing the trailer to obtain warranty service.

THIS WARRANTY WILL NOT APPLY IF A COMPLETED WARRANTY REGISTRATION IS NOT ON RECORD WITH GVI. ALSO, A CERTIFICATE OF INSURANCE MUST BE SUBMITTED FOR VALIDATION. Purchaser is responsible for all costs incurred to obtain Warranty service, including towing, transportation, meals, and lodging expenses.

ROUTINE MAINTENANCE RESPONSIBLE OF PURCHASER:

Trailer axle bearings

Every 6 months or 6000 miles to be regreased or replaced as needed

Drive motor

Chain tension - Tension of chain on main drive motor is inspected weekly ensuring chain is tight and secure, and there is no visual play. Proper tension is required for the system to operate correctly. A loose chain can and will cause the system to jump, slam, and possibly break if not kept snug to the main sprocket.

Mounting brackets

Mounting brackets and bolts are checked weekly along with chain tension ensuring all bolts are fully tightened and not loose.

Belt chain

Chain Tension - Chain tension is inspected weekly to ensure the chain is kept tight, not loose, and has no play. Improper tension of the chain will cause improper unloading and loading of material and can and will result in damaging crossbars/push-off bars.

Chain debris - Chain is inspected weekly for debris and debris removed as needed to ensure proper functionality

Hydraulic System

Hydraulic fluid - Checked weekly to ensure there are no leakes and fluid is added or replaced to the fill line as needed to ensure proper functionality of the rams during operation.

Hydraulic lines - Checked weekly to ensure proper connection and for any damage to lines. Replace as needed.

Door Hinges - Greased monthly as needed.

LIMITATION OF LIABILITY

IN CONNECTION WITH THIS WARRANTY, GVI EXCLUDES ALL LIABILITY, WHETHER BASED, ON CONTRACT (EXPRESS OR IMPLIED), TORT, OR PRODUCT LIABILITY, FOR ANY DAMAGES OTHER THAN THE LIABILITY ASSOCIATED WITH THE REPAIR OF ANY DEFECTIVE ITEM AS SET FORTH IN THIS WARRANTY. GVI ALSO SHALL NOT BE LIABLE FOR ANY PUNITIVE, SPECIAL, INDIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGES OF ANY KIND, OR FOR LOSS OF REVENUE, PROFITS, LOSS OF BUSINESS, LOSS OF USE OF THE PRODUCT, ATTORNEY FEES, OR OTHER FINANCIAL LOSS ARISING OUT OF OR IN CONNECTION WITH THE SALE, MAINTENANCE, USE, OR FAILURE OF THE TRAILER, EVEN IF GVI HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. GVI'S LIABILITY UNDER THIS WARRANTY DOES NOT INCLUDE, AND SPECIFICALLY EXCLUDES, LIABILITY FOR THE PURCHASER'S HOTEL OR OTHER LODGING EXPENSES, FOOD AND OTHER LIVING OR TRAVEL EXPENSES, AND FUEL EXPENSES.

LIMITATIONS OF IMPLIED WARRANTIES

GVI MAKES NO EXPRESS OR IMPLIED WARRANTIES OTHER THAN AS SPECIFICALLY SET FORTH IN THIS WARRANTY. GVI EXPRESSLY LIMITS THE DURATION OF ALL IMPLIED WARRANTIES OF MERCHANTABILITY, ALL IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE, AND ALL OTHER IMPLIED WARRANTY PERIODS ARE EXPRESSLY LIMITED TO THE EXPRESS WARRANTY PERIODS SET FORTH IN THIS WARRANTY. ALL IMPLIED WARRANTIES OF MERCHANTABILITY AND ALL IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE ARE HEREBY DISCLAIMED AFTER EXPIRATION OF THE EXPRESS WARRANTY PERIODS.

DESIGN CHANGES

GVI reserves the right to change the design of its HAULIT from time to time without notice and without obligation to make corresponding changes in any HAULIT previously manufactured.

LEGAL REMEDIES OF PURCHASER

THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, OTHER RIGHTS MAY VARY FROM STATE TO STATE. No action to enforce this Warranty shall be effective if it is commenced after the expiration of the applicable Warranty Periods set forth above, or later than 14 days after the discovery of the defect-whichever date is earliest. Damage done to other warrantied parts because of negligence of the purchaser is not the responsibility of GVI.
